3. Da sam kao vozač svjestan svih rizika koje donosi automobilistička i motociklistička aktivnost na stazi
4. Da sam upoznat da vožnje u autu ili na motoru, iako amaterskog karaktera, predstavljaju rizik za sigurnost osoba i imovine i da preuzimam svu direktnu, indirektnu i osobnu odgovornost te se ovom izjavom oslobađa svih odgovornosti Automotodrom Grobnik d.o.o. i Grobnik servis d.o.o. i svo osoblje na stazi
5. Da sam upoznat sa cjenikom i svim aktualnim uvjetima za korištenje staze, te da ih prihvaćam
6. Da poznajem propise koje treba slijediti kod korištenja staze i obvezujem se slijediti upute autoriziranog osoblja na stazi
7. Da preuzimam svu odgovornost za štete i ljudske ozljede koje sam uzrokovao ili koje su uzrokovale osobe u mojoj pratnji tokom korištenja staze, u parku vozača i isključujem iz svih odgovornosti Automotodrom Grobnik d.o.o. i Grobnik servis d.o.o. i njegove djelatnike
8. Da izuzimam iz svih odgovornosti Automotodrom Grobnik d.o.o. i Grobnik servis d.o.o. za eventualne krađe ili oštećenja koje bi se mogle desiti unutar automotodroma, staze, parka vozača, ugostitelja, sanitarnih čvorova, ureda i slično, uključujući i samu okolinu automotodroma
9. Izuzima se Automotodrom Grobnik d.o.o. i Grobnik servis d.o.o. od bilo kakve odgovornosti za pretrpjele štete zbog pada i gubljenja stvari na stazi (npr.: transponder, zastave, gume i dr.)
10. Da prihvaćam da Automotodrom Grobnik d.o.o. i Grobnik servis d.o.o. prekine moju vožnju u svakom trenutku ili mi zabrani vožnju u nekim danima zbog neprikladnog, nekulturnog i nesportskog ponašanja s moje strane. Uz takvo ponašanje nemam pravo tražiti povrat uplaćenog treninga.
11. Prihvaćam činjenicu da loše vrijeme, bilo koje vrste, ne daje pravo na povrat naknade bilo koje vrste od strane Automotodrom Grobnik d.o.o. i Grobnik servis d.o.o.

Isključivo je moja odgovornost naknada štete koju sam uzrokovao direktno ili indirektno na objektima automotodroma, ostalim vozačima i njihovim vozilima, trećim stranama bili oni posjetitelji, organizatori ili djelatnici Automotodrom Grobnik d.o.o. i Grobnik servis d.o.o., isključujući od odgovornosti Automotodrom Grobnik d.o.o. i Grobnik servis d.o.o.
13. Tijekom amaterskih utrka, razina natjecanja je amaterska, te zahtijeva veći stupanj pažnje.
14. Da koristim vozilo u skladu sa zahtjevima aktivnosti kojom se bavim, da koristim svu odgovarajuću i propisanu odjeću i obuću, te da sam u odličnom psihičkom i fizičkom stanju. ### STATEMENT ON TAKING PERSONAL RESPONSIBILITY

1. That I have personally inspected the track and infrastructure, and accordingly consider them safe and suitable for the use in all aspects
2. That I am familiar with the possibilities of medical service, both passive and active ones, and that I consider them to be safe and optimal for the planned activities on the track
3. That as a driver/rider I am aware of all the risks that could come out of any motorsport activity done with car/motorcycle on the track
4. That I am familiar and aware of the fact that driving a car or motorcycle, although the amateur nature, pose a risk to the safety of persons and property and that I take all direct, indirect, and personal responsibility, and with this statement I hereby release Automotodrom Grobnik Ltd. and Grobnik servis Ltd. and all the staff on the track from any responsibility
5. That I am familiar with the price list and all actual conditions for using the track and that I accept them
6. That I know the rules to be followed when using the track and that I oblige to follow the instructions of authorized personnel on the track
7. That I take all responsibility for damages and human injuries that I have caused or are caused by the people in my escort during the use of the track, in the paddock and hereby I exclude Automotodrom Grobnik Ltd. and Grobnik servis Ltd. and its employees from any responsibility
8. That I exclude Automotodrom Grobnik Ltd. and Grobnik servis Ltd. from all responsibilities for any theft or damage that may occur within Automotodrom, track, paddock, caterers, sanitary, offices, etc., including the very environment of Automotodrom
9. Automotodrom Grobnik Ltd. and Grobnik servis Ltd. are excluded from any responsibility for damages caused by fall and lose things on track (transponder, flags, tires, etc)
10. That I accept that Automotodrom Grobnik Ltd. and Grobnik servis Ltd. terminate my driving at all times or ban my driving on some days due to inappropriate and unsportsmanlike behavior on my part. With such behavior I have no right to claim refund of paid training.
11. I accept the fact that the bad weather of any kind, does not entitle me to claim the refund of reimbursement of any kind from Automotodrom Grobnik Ltd and Grobnik servis Ltd.
12. It is solely my responsibility all the damages that I've caused, directly or indirectly to the facilities of the Automotodrom, to the other drivers and their vehicles, to the third parties – visitors, organizers or employees of the Automotodrom Grobnik Ltd. and Grobnik servis Ltd. excluding with this Automotodrom Grobnik Ltd. and Grobnik servis Ltd. from any kind of responsibility
13. During the amateur race, level of competition is amateur one and requires a greater degree of attention
14. That I use the vehicle in accordance with the requirements of the activities that I do, that I use all appropriate and restrictive clothing and shoes, and that I am in excellent mental and physical condition. Hereby I confirm that I will not lend my vehicle to the people who go out on the track and who have not signed this statement about taking personal responsibility, and also accept all civil, criminal and administrative responsibility
15. That I have read this statement, and I'm familiar with it and aware of all rules of Automotodrom Grobnik Ltd. and Grobnik servis Ltd. and of conduct on the track
16. That I am aware that the failures on the vehicle or possible falls of any kind (including crashes or contacts with the drivers) do not provide any possibility of a refund and compensation of the claims in relation to Automotodrom Grobnik Ltd and Grobnik servis Ltd.
17. That I have personal insurance that covers a variety of injuries
18. That I accept the fact that I can drive on the track, and only after I attended the instructions on how to conduct and about rules to follow on the track
19. That I am familiar with a number of track marshals on the track and that I consider it to be adequate for safe driving
20. That I will obey the speed limit in the pit lane of 60km/h
21. That I will obey the speed limit outside the track and within the facilities of the Automotodrom of 30km/h
22. That I am familiar with the Privacy policy and GDPR regulations of Automotodrom Grobnik Ltd.
